CONTINGENCY QUANTITIES (06/19/2006)

THE CONTRACTOR SHALL NOT ORDER MATERIALS OR PERFORM WORK FOR ITEMS DESIGNATED BY PLAN NOTE TO BE USED "AS DIRECTED BY THE ENGINEER" UNLESS AUTHORIZED BY THE ENGINEER. THE ACTUAL WORK LOCATIONS AND QUANTITIES USED FOR SUCH ITEMS SHALL BE INCORPORATED INTO THE FINAL SUBSIDIARY AGREEMENT GOVERNING COMPLETION OF THIS PROJECT.

Designer Note: Contingency quantities are those included in the plan to be used only as necessary depending on conditions found during construction. A contingency quantity should be used when no reasonable method of estimating the quantity is available to the designer. Typically, this quantity should not be more than 15% of the total contract quantity. The above note should be used whenever plan notes specify quantities to be used "as directed by the engineer".

THE INSTALLATION, AND OPERATION (INCLUDING ERECTION, MAINTENANCE AND REMOVAL) OF ALL WORK ZONE TRAFFIC CONTROL AND WORK ZONE TRAFFIC CONTROL DEVICES REQUIRED BY THESE PLANS, EXCEPT WHERE OTHERWISE NOTED, SHALL BE PROVIDED BY THE CONTRACTOR WHETHER INSIDE OR OUTSIDE THESE WORK LIMITS.

IN ADDITION TO THE REQUIREMENTS OF SECTION 614.05, THE CONTRACTOR SHALL FURNISH, ERECT, MAINTAIN, AND SUBSEQUENTLY REMOVE ALL WORK ZONE TRAFFIC CONTROL AND WORK ZONE TRAFFIC CONTROL DEVICES, INCLUDING SUCH ADDITIONAL TRAFFIC CONTROL DEVICES LOCATED OUTSIDE THE LIMITS OF CONSTRUCTION AS ARE REQUIRED ON HIGHWAYS WHICH ARE USED AS DETOURS, INCLUDING THE "ROAD CLOSED" SIGNS UPON THE BARRICADES AT THE POINT WHERE THE HIGHWAY IS CLOSED TO THROUGH TRAFFIC.

PROGRESS MEETINGS WILL BE HELD EVERY FOUR (4) WEEKS AT THE PROJECT OFFICE OR OTHER LOCATION DESIGNATED BY THE AREA CONSTRUCTION ENGINEER, AND WILL BE ATTENDED BY COUNTY AND CONTRACTOR DECISION-MAKING PERSONNEL.

THE PURPOSE OF THESE MEETINGS IS TO DISCUSS CRITICAL OPERATIONS AND POTENTIAL PROBLEMS. ALSO, THE CONTRACTOR WILL CONFIRM THE NUMBER AND DURATION OF WORK SHIFTS, NUMBER OF WORK CREWS, AND SPECIFIC PORTIONS OF THE WORK TO BE PERFORMED DURING THE FOLLOWING WEEKS.

THESE MEETINGS CAN ONLY BE WAIVED BY THE AREA CONSTRUCTION ENGINEER.

ALL REFERENCES TO THE GENERAL PROVISIONS (SECTION 100) OF THE OHIO DEPARTMENT OF TRANSPORTATION'S CONSTRUCTION AND MATERIAL SPECIFICATIONS (ODOT CMS) THAT ARE CITED IN THE ITEMIZED SPECIFICATIONS, SUPPLEMENTAL SPECIFICATIONS, PROPOSAL NOTES, PLANS OR ELSEWHERE IN THE CONTRACT DOCUMENTS SHALL, FOR THE PURPOSE OF THIS CONTRACT, BE CONSIDERED AND TAKEN AS MEANING THE CUYAHOGA COUNTY ENGINEER'S GENERAL PROVISIONS AS CONTAINED IN THE "CUYAHOGA COUNTY ENGINEER SPECIFICATION BOOKLET". THE SUBSECTION NUMBERS AND TOPICS USED IN THE COUNTY'S GENERAL PROVISIONS CORRESPOND TO THOSE CONTAINED IN THE ODOT CMS.

COOPERATION BETWEEN CONTRACTORS (10/31/2013)

IT IS ANTICIPATED THAT OTHER CONTRACTORS WILL BE WORKING ON PROJECTS ADJACENT TO OR WITHIN THE LIMITS OF THIS PROJECT, EITHER FOR THE COUNTY OR FOR OTHER PUBLIC AGENCIES. THE CONTRACTOR SHALL COOPERATE AND COORDINATE HIS/HER OPERATIONS, INCLUDING PROVISIONS FOR THE MAINTENANCE OF TRAFFIC, WITH THE CONTRACTORS OF OTHER PROJECTS THAT MAY BE IN FORCE DURING THE LIFE OF THIS CONTRACT. THE CONTRACTOR'S ATTENTION IS SPECIFICALLY DRAWN TO SECTION 105.08 OF THE CUYAHOGA COUNTY ENGINEER'S GENERAL PROVISIONS. NO WAIVER OF ANY OF THE PROVISIONS OF SECTION 105.08 IS INTENDED.

DUST CONTROL (09/29/2008)

THE CONTRACTOR SHALL FURNISH AND APPLY WATER AND CALCIUM CHLORIDE FOR DUST CONTROL AS DIRECTED BY THE ENGINEER. THE FOLLOWING ESTIMATED QUANTITIES HAVE BEEN INCLUDED FOR DUST CONTROL PURPOSES:

ITEM 616 – CALCIUM CHLORIDE	_____ TON

Designer Note: County version of ODOT's TEM Note 642-19. For every cubic yard of earthwork (embankment plus excavation), use between 0.002 M Gal. and 0.004 M Gal. of water. The lower rate should be used for small and/or rural projects and the larger rate should be used for large and/or urban projects. For every 10 M Gal. of water assume 1 Ton of calcium chloride.

WORK ON MORE THAN ONE ROAD (10/31/2013)

THIS PROJECT INCLUDES WORK ON MORE THAN ONE (1) ROAD. THE CONTRACTOR MAY WORK ON TWO (2) OR MORE ROADS SIMULTANEOUSLY SUBJECT TO THE SPECIFIC WRITTEN APPROVAL OF THE ENGINEER. THE FOLLOWING REQUIREMENTS APPLY TO THIS CONTRACT:

1. THE PROGRESS SCHEDULE REQUIRED IN 108.03.A SHALL ALSO SHOW THE CONTRACTOR'S PLAN TO CARRY OUT THE WORK REQUIRED ON EACH ROAD INDIVIDUALLY AND GIVE START AND COMPLETION DATES FOR EACH ROAD.
2. THE REQUIREMENTS OF 108.03 SHALL APPLY SPECIFICALLY TO EACH ROAD.
3. THE REQUIREMENTS OF 108.04 SHALL APPLY SPECIFICALLY TO EACH ROAD. IN DETERMINING WHETHER THE CONTRACTOR HAS COMPLIED WITH THE REQUIREMENT TO ASSURE THE LEAST INTERFERENCE WITH TRAFFIC, THE ENGINEER SHALL ADDITIONALLY TAKE INTO CONSIDERATION SUCH FACTORS AS:
 - A. THE LENGTH AND DURATION OF LANE CLOSURES.
 - B. THE RIDEABILITY OF ANY PLANED SURFACES WITH PARTICULAR ATTENTION GIVEN TO CASTING HEIGHTS AND DRIVE ACCESS CURB HEIGHTS.
 - C. ACCESS TO DRIVEWAYS.
 - D. UNNECESSARY PERIODS OF INACTIVITY BY THE CONTRACTOR.
 - E. WHETHER THE OPENING OF WORK ON A SECOND ROAD WILL BE TO THE PREJUDICE OR DETRIMENT OF WORK ALREADY BEGUN ON ANOTHER ROAD.
4. THE REQUIREMENTS OF 108.05 SHALL APPLY SPECIFICALLY TO EACH ROAD. THE CONTRACTOR SHALL AT ALL TIMES EMPLOY SUFFICIENT LABOR AND EQUIPMENT FOR PROSECUTING THE SEVERAL CLASSES OF WORK TO FULL COMPLETION IN THE MANNER AND TIME REQUIRED BY THESE SPECIFICATIONS.
5. LIQUIDATED DAMAGES, BASED ON THE TOTAL CONTRACT AS SPECIFIED IN 108.07, SHALL APPLY FOR EACH CALENDAR DAY THAT A SPECIFIED ROAD REMAINS UNCOMPLETED AFTER THE ROAD'S SPECIFIC COMPLETION DATE, AS DETERMINED BY THE CONTRACTOR'S ORIGINALLY APPROVED PROGRESS SCHEDULE. DUE ACCOUNT WILL BE TAKEN OF ANY ADJUSTMENT OF THE SPECIFIC ROAD'S COMPLETION DATE GRANTED UNDER 108.06.

ITEM 614 - MAINTAINING TRAFFIC, AS PER PLAN
ITEM 624 – MOBILIZATION, AS PER PLAN (09/29/2003)

PAYMENT FOR LUMP SUM ITEMS

IN CONJUNCTION WITH SECTION 109.09 OF THE SPECIFICATIONS, THE ABOVE REFERENCED "LUMP SUM" ITEMS SHALL BE PAYABLE TO THE CONTRACTOR AS SPECIFIED BELOW:

1. THE BASIS OF PAYMENT FOR EACH OF THE ABOVE LUMP SUM ITEMS WILL BE THE CALCULATED RATIO OF THE LENGTH OF WORK COMPLETED ON EACH ROAD COMPARED TO THE TOTAL LENGTH OF ALL ROADS IN THE CONTRACT.
2. THE CONTRACTOR WILL ONLY RECEIVE THE CALCULATED DOLLAR AMOUNT FOR EACH SPECIFIED ROAD. IF ANY ROADS ARE ADDED OR DELETED, THE "LUMP SUM'S" AMOUNT WILL EITHER BE INCREASED OR DECREASED ACCORDING TO THE METHOD DESCRIBED IN NO. 1 ABOVE.
3. FOR ITEM 624 - MOBILIZATION, AS PER PLAN, THE CONTRACTOR WILL RECEIVE THE PROPORTIONAL DOLLAR AMOUNT SPECIFIED IN SECTION 624.02 OF THE SPECIFICATIONS ON EACH OF THE ROADS, AS SPECIFIED IN THIS CONTRACT, UNLESS OTHERWISE DIRECTED BY THE ENGINEER.
