II. Call to Order

Mr. Roche called the meeting to order with participant introductions at 10:05 am while Dan DiGiammarino recorded the minutes.

III. Council Introductions

Chairman Roche welcomed everyone to the meeting, he then asked each member to introduce themselves, and each member in turn introduced themselves and the organization they represent.

IV. Election of Officers

Chairman Roche called for nominations for Chairman of the Noise Abatement Committee, Councilman Plecnik, and nominated Cathy Murphy which was seconded by Chairman Roche. Chairman Roche asked for any further nominations, no other nominations were made. Chairman Roche called for a vote Cathy Murphy to serve as Chair of Noise Abatement Committee. **Unanimously approved.** Chairman Roche called for nominations for Co-Chair of the Noise Abatement Committee; Councilman Plecnik nominated Mayor Roche which was seconded by Dan Frisone. A vote was called for Mayor Roche to serve as Co-Chair of the Noise Abatement Committee. **Unanimously Approved.**

V. Approval of the Minutes

Mr. Roche called for discussion for the October 8, 2015 NAC meeting minutes and needed corrections. NAC Secretary DiGiammarino provided a short description of needed corrections, after which a vote was called for the approval of the minutes from the October 8, 2015 meeting. **Unanimously approved.**

VI. Noise Complaints

Mr. Roche called upon Dan DiGiammarino to report the noise complaints. The fourth (4th) quarter had 6383 operations from October 1, 2015 to December 31, 2015. Reports indicate that one hundred and four (104) complaints were received. Twenty two (22) complaints occurred between 0700L and 2300L. Eighty two (82) complaints occurred between the hours of 2300L and 0700L. One (1) general complaint the airport logged one hundred twenty five (125) VNA hour operations. Mr. DiGiammarino described the findings of the complaints. Mr. Huth explained that the FAA did have problems with Falcon III radar data was not available for replay and a number of complaints were not able to be researched but radar replay.

All noise complaints reflected with VNA on the noise abatement complaint spreadsheet reflect those that occurred during the hours of 2300 to 0700.

VII General Discussion

Chairman Roche open the floor to general discussion at which time he asked Scott Huth about the issue of drones operating in the vicinity of the airport. Scott Huth gave a short overview of operation of drones, a short discussion on what is a drone and what areas they are permitted to operate. Scott Huth will forward the most up to date information he has been provide by the FAA in regards to drone operations. Cathy Murphy brought up the subject and towers and lighting of towers, a short discussion as to how it is determined what needs to be lighted. Mr. Roche reminded the Committee of a public meeting on January 26th to discuss Project #1. A short discussion in regards to the operational constraints of the airport during the construction of Project #1 and notification of upcoming airport closures.

VIII Joint Statement

Chairman Roche began the discussion on the updated Joint Statement; the committee discussed the changes to the Joint Statement. A short discussion took place regarding who would be the County signers of the document, as well as the process. Aaron Thayer made a motion to submit a draft Joint Statement along with a cover letter explaining the changes to the County Executive Scott Huth seconded the motion. Chairman Roche called for a vote on the motion, **Motion passed with Councilman Plecnik voting No**

IX. Public Comment

Mr. Roche opened the floor to public comments,

Marie Ratino, questioned safety and security during the RNC as well as departure paths during construction. She also asked that the small planes issue be taken care of to eliminate them from flying over their homes. Dan DiGiammarino along with Mr.Roche stated the security will be increased but it will not be made public. The committee advised her that the departure will not change during the construction. Chairman Roche advised her that we have been working on this and will continue to make sure departures are in accordance with established procedures.

Chairman Roche asked for the upcoming schedule for Noise Abatement meetings the following dates were April 11, 2016, July 14, 2016, October 13, 2016 all of which will begin at 10a.m. Chairman Roche proposed a motion to approve those dates which was seconded by Cathy Murphy, a vote was called and the motion was **Unanimously Approved**
